Notes for Table 1:

- This data provides a count of distinct victims with a referral to a Family Violence service per month.
- This data consists of all referrals to Safety Programmes and Strengthening Safety Services.
- If a victim has a referral to more than one Court within the same month, they will be counted once in each Court.
- The Ministry of Justice collates data at the end of each month, not on the first. This means that figures have been provided as at the last day of the previous month.
- The way we have interpreted this data has improved since responding to 35337(2019).
