

What items of secondary legislation, if any, listed by title, are administered by the Minister's departments, agencies, crown entities and any other bodies that the Minister is responsible for, if any?

The following items of secondary legislation are administered by agencies within the Finance portfolio, grouped by agency and by the principal Act under which they were made. This list does not include:

- secondary legislation which has been revoked;
- secondary legislation administered by agencies listed below, but where the relevant legislation is located in portfolios other than Finance; and
- amendment secondary legislation (e.g. where changes made by the secondary legislation have been incorporated into a principal Act, such as updating a Schedule in an Act).

The below list may not be exhaustive, and judgements were required to be made as to whether particular items were included or excluded from the list, in cases where secondary legislation items are still in force but were made under a principal Act which has since been repealed, such that the principal Act has no assigned portfolio.
