- *Orders made under clause 21 of Schedule 3 to the Customs and Excise Act 2018 changing the rate of duty on alcoholic products and tobacco products specified in the EEDT. These Orders are made annually. The two most recent examples are the Excise and Excise-equivalent Duties Table (Tobacco Products Indexation and Reduction) Amendment Order 2024 and the Excise and Excise-equivalent Duties Table Order 2024 and the Excise and Excise-equivalent Duties Table (Alcoholic Beverages Indexation) Amendment Order 2025.*
- *Orders made under clause 25 of Schedule 3 to the Customs and Excise Act 2018 amending tariff headings and items in the EEDT. The most recent example is the Excise and Excise-equivalent Duties Table (Residual Fuel Oil) Amendment Order 2025.*
