**Notes for Table 1:**

- “Full Hearing” has been interpreted as a hearing that is likely to result in the case being disposed of. Hearings that have not resulted in a case disposal have not been considered in this data.
- The number of months is calculated as between application filing date and 30 November 2022.
- Statistics are based on the Case Management System as at 12 December 2022. Since this is an operational system, data for earlier months may have been updated since any previous publications.
- The Ministry of Justice collates data at the end of each month, not on the first.
- Application types included for parenting orders are: s47 Consented Parenting Order, s47 Leave to Apply for Parenting Order, s47 Parenting Order, s56 Discharge of Parenting/Other Orders, s56 Variation of Parenting/Other Orders, s57 Consented Variation.
- Only court locations with active Parenting Order applications as at 30 November 2022 with a future hearing scheduled are shown in the table above.

- The court location represents the court managing the case, which may not be the court where the hearing is scheduled. Small courts often have long cause hearings scheduled to occur in the main court in their area.
